The Plight of Adjuncts in Higher Education

The most common adjunct used was pelvic binder (50%) followed by no adjunct (30.5%); least common was resuscitative balloon occlusion of the aorta (REBOA) (2.5%). Preperitoneal packing alone and REBOA alone/with other adjunct(s) resulted in the fastest times to operating room/interventional radiology but also had the highest blood utilization and mortality rates.

Treatment of Adjunct Faculty. Section 4980H of the Internal Revenue Code (added by the ACA) requires employers with 50 or more employees to provide full-time workers with health insurance coverage or face tax penalties. Under the ACA, a "full-time employee" is defined as an individual who works 30 or more hours per week.
